From Toolkit to training materials...

PROJECT WORKPLAN

All project partners will analyse and discuss the manual/toolkit in order to elaborate its final version and **prepare the training materials and training courses for possible counsellors.**

Coordinator will update the **toolkit final version** according to the Exchange seminar results and **will send it to ETUC in order to disseminate the toolkit among EU trade union members.**

<u>Milestones</u>: Partnership meetings. Result-sharing of the previous project activities. Final version of toolkit in English in order to disseminate it to workers and their representatives in other countries not involved in the project. <u>Common training materials</u>.

<u>**Deliverables:**</u> final version of toolkit in English. (Exchange-seminar and first-PMG-meeting minutes).





Duration: 7 months

Original Timetable: from the 12th to the 18th month of the action

Objectives:

- Translation of the toolkit in national languages;
- Identification and training of just-transition counsellors;
- define a transnational dimension of just transition through a transnational exchange of national experiences and tools.





Activities:

- Each project partner will **translate the manual/toolkit** in its own language in order to facilitate its dissemination in the countries involved in the project.
- Each project partner will identify a team of possible counsellors and a trainer at national level.
- In this phase Vorming & Actie vzw will strictly work with CISL in preparing training materials and methodologies according to exchange seminar decisions.
- Project partners, coordinated by lead applicant, will adjust training materials and methodologies according to their country characteristics.



Each project partner will train the counsellors identified in its country according to the project objectives and using the common training materials.

The **Italian national training course** will serve as a **pilot course** in order to evaluate the efficacy of the tools and methodologies and, possibly, refine these, in accordance with co-applicants, for the next national courses.

A Belgian trainer will participate at the Italian training course in order to share the experience and support Coordinator in evaluate the efficacy of the tools.







Each training national course will last 2.5 days and will involve the possible counsellors and sectoral/national/local/company trade unionists.





After national trainings it will be scheduled **a transnational training** organized by the coordinator at the Cisl National Study Center of Florence **in order to:**

- share national experiences and tools;
- discuss the transnational dimension of just transition.

The transnational training will last 2.5 days.





The participants will be selected including the trainees at national level mostly involved in international and transnational sectors and companies.

The training team for this course will include a trainer from each co-applicant and will be coordinated by the Cisl.

Interpretation will be provided according to the language skills of participants.





Milestones:

- Adaptation of common training materials to the characteristics of each project country.
- Provide a **shared national-language toolkit** in all the countries involved in the project.
- Prepare a **team of just-transition experts** (counsellors) in order to support workers and their representatives at company level in managing just-transition.
- Build a transnational community of practices of counsellors through the transnational training.





Deliverables:

- Toolkits in national languages of countries involved in the project;
- **Training materials** with regard of national and transnational characteristics.
